

Volunteer Participation Policies

Eligibility

The minimum age to volunteer for most job assignments is 16.

Volunteer Sign-up Process

To sign up for a volunteer assignment, please create a volunteer account within the Universities of Wisconsin VolunteerMatters system, which is the volunteer management program used by PBS Wisconsin for volunteer recruitment. Once a volunteer account has been created in VolunteerMatters, individuals may sign up for available volunteer opportunities within the system. Prospective volunteers will be subject to a criminal background check prior to volunteering.

Criminal Records Check

PBS Wisconsin will conduct criminal background checks on prospective volunteers ages 18 and older. Criminal charges that will preclude participation in the volunteer program include fraud, theft, violent crimes, or other relevant situations as determined by program staff.

Preparation

Review your job description prior to your shift to ensure you can complete the assigned duties and meet the job requirements. Job descriptions are posted on the PBS Wisconsin event pages within the VolunteerMatters portal. You can also contact the volunteer office to request a written copy. PBS Wisconsin reserves the right to place volunteers into positions that best match their skills.

Dress Code

Because PBS Wisconsin is a non-partisan organization serving a broad and diverse community, political shirts and other campaign apparel are prohibited.

Training

Training and orientation will be offered at the beginning of your shift. All volunteers are required to attend training as this session will help prepare you for your job duties.

Evaluation

Volunteer supervisors and staff will provide you with constructive feedback during your shift as appropriate.

Cancellation

Please contact us at least 24 hours in advance in the event you need to cancel your job assignment. This will give us time to find a replacement for you.

Confidentiality

Volunteers are responsible for maintaining the confidentiality of all sensitive information to which they are exposed while serving as volunteers, including member and donor financial information such as bank account number, credit card number, and personal identifying information such as mailing addresses, email addresses, phone numbers, etc.

Reasonable Accommodation Policy

It is the policy of PBS Wisconsin to provide reasonable accommodations for qualified volunteers with disabilities. Volunteer Dismissal

Reasons for immediate termination include, but are not limited to:

- Poor, inconsistent attendance and/or performance.
- Profanity, harassment, and/or discrimination.
- Unauthorized possession or destruction of PBS Wisconsin property.
- Engaging in acts of dishonesty, fraud, or theft.
- Conviction of felony charge.
- Other situations as deemed relevant by program staff.
